1. Briefly describe the project. What was done, when and where did project activities take place, and who were the beneficiaries?

The city Blessing Boxes are honor system food pantries where people can take food and hygiene supplies for those in need in the Placentia Community. The boxes are used on a daily basis and are important to provide sufficient supplies to prevent hunger in the community. Placentia Rotary, since the beginning of the program, has been a significant contributor to the boxes. The club also ensured that the boxes were kept sanitary and in good repair. This year, other city groups helped cover the post-Christmas holiday period. Rotary will again take the lead for the spring and summer sessions. The club also included the Veteran's Village in the program.

2. How many Rotarians participated in the project?

10 in planning/six executing

3. What did they do? Please give at least two examples.

Approximately 10 Rotarians participated in a club assembly where the project was proposed. Since it was such a success in prior years, there was almost unanimous consent to continue the project and include the Placentia Veterans Center as well. Since there were still some supplies remaining from the previous year, the club continued to distribute supplies until they were gone. There were six members who regularly visited the boxes and delivered food purchased by the club. The club also involved Interact students who needed service hours towards their graduation requirement.

4. How many non-Rotarians benefited from this project?

Several hundred according to city officials who track the program

5. What are the expected long-term community impacts of the project?

City residents who are hardest hit by the pandemic and worsening economy are better able to function without hunger. This enables them to remain productive community residents.
