Camp RYLA at the Boys and Girls Club Tijuana June 15th--COMPLETED

On June 15th the Members of MBSR spouses, Rotaract Tijuana, RYLA Leadership NU, Rotary E-Club Noroeste, District 5320 RYLA counselors and bilingual leadership came to the Boys and girls Club of Tijuana, Baja California to develop and participate on a RYLA activity program to help and teach kids about leadership. We had 86 kids actively attending from the community and neighbor schools.

2. How many Rotarians participated in the project? 6-rotarians MBSR 5-Tijuana e-Club Rotary, 3-RYLA Director and counselors, 5active District 5320 past RYLA students, 6 Boys and Girls volunteers.

3. What did they do? Please give at least two examples.

We conducted activities from 10am to 3pm for 86 students to build communication, engagements between the attendees, leadership and awareness.

4. How many non-Rotarians benefited from this project? We benefited 86 students and club staff.

5. What are the expected long-term community impacts of the project?

The RYLA program is for youth between ages of 12-18.They will acquire new "roots" through leadership programs. The day activity provides interaction between the kids; hands on assignments of groups, team development with different subject's school teaching curriculum and better understanding of community.

Boys and Girls Club provided staff, space for the activities, food and personnel for support.
