### Basic Information About IPP-

At the Idaho Playground Project we are dedicated to empowering lives through play. Our mission is to provide every child equal access to play experiences through playgrounds, toys, books, and games. Recognizing the disparities in access to adaptive playground equipment, our organization aims to bridge the gap by addressing financial barriers and providing essential resources to establish inclusive environments for all. Over the next ten years, Idaho Playground Project aims to build 100 adaptive playgrounds in elementary schools across Idaho. Our initiative extends beyond just infrastructure, and strives to provide education, advocacy, and opportunity for accessible community programs for children of all abilities. We are excited to be partnering with Harrison Elementary School in Twin Falls for our very first adaptive playground partnership.

As a newly established nonprofit organization, we are dedicated to maximizing our community impact. As part of this commitment, we require that our school partnerships maintain their playgrounds open for community use after school hours and during school breaks. Harrison Elementary School currently serves a total of 385 students. Among these students, 111 are enrolled in either the special education program or developmental preschool, indicating a significant portion of the student body receives specialized educational services to support their individual needs. While quantifying the precise number served is challenging, this playground is intended to benefit thousands within the broader Twin Falls community, extending beyond just the boundaries of Harrison Elementary School students.

### Ways Your Club Can Volunteer-

We are having a golf tournament on Saturday October 4 and need a lot of volunteers to help us run the tournament as this is our first time doing a golf tournament.

After the first of the year we will have an Auction and Trivia night that we will need help with.
