Dear Rotarians Shetty and Cadwallader,

Congratulations! Your Matching Grant application, submitted by Rotary Club of Nitte and Rotary Club of El Camino Real for funding to provide basic infrastructure facilities to the rural school Sri Vidya Bodhini Higher Primary School in Karkala, India, has been approved by Rotary Foundation (India) ("RF(I)") and The Rotary Foundation ("TRF"). The award is in the amount of INR253,125.00 equivalent to US\$5,625. The total grant budget for the project is INR675,000.00 equivalent to US\$15,000.00.

This letter is your formal notification and describes the enclosed forms. In all cases, the primary partners must both sign the **Agreement Form** and ensure correct **Payee Information** is sent to RF(I) and TRF. Any additional information and/or sponsor contributions that RF(I) and TRF requires in order to make grant payment are described in the Agreement Form and the **Sponsor Contributions Form.** 

- A. **Agreement Form**. Be certain to refer to this document throughout the implementation of the project to help ensure compliance with RF(I) and TRF requirements.
- B. **Sponsor Contributions Form**. This form gives instructions for sending cash (non-SHARE/DDF) contributions to RF(I) and TRF. It is <u>not</u> included if your project is financed solely through SHARE/DDF contributions.
- C. **Payee Information Form**. Coordinate with your partner to establish an appropriate payee. Complete and return the form to inform RF(I) and TRF where the grant payment should be sent.

Each partner is sent a copy of the forms. The same document need not be signed by all partners. Keep a copy of the signed forms for your records before returning the forms to TRF. Faxes are acceptable, and originals are not required. It is extremely important to remain in constant contact with your partner to ensure the above requirements are completed.

Additional information you will find helpful is included. (If you are receiving this document via e-mail, please see the accompanying e-mail message for links to the documents on the RI website.)

- 1. Terms and Conditions of Matching Grant Award for Projects in India. Read this document carefully, and refer to it when you have questions about RF(I) and TRF requirements.
- 2. **Report Form**. Reporting on your project is mandatory. Progress reports are due every twelve months, and a Final Report must be submitted within two months of your project's completion. For India specific grants, please ensure that all reports **must** be sent to RF(I) for the periods ending 30 September and 31 March, with reports due by 30 November and 31 May. Audited accounts are mandatory with Final Reports and 31 March Report. Along with the Final Report and 31 March Report, original financial documents including receipts and vouchers must be included in the reports. In order to ensure closure of grant files by RF(I) and TRF, all requirements must be met as stipulated by RF(I)
- 3. **Humanitarian Programs Promotional Guide** has information about how to promote in your community and in the media. A promotional plan is required before payment will be issued for grant awards of Indian Rupees equivalent to US\$25,001 or more.
- 4. **Paul Harris Fellow Recognition/Contribution Form** can be used to receive Paul Harris Fellow (PHF) credit for cash contributions sent to RF(I) and TRF.

The Rotary clubs and districts in India have been granted exemption under Section 6 of the FCRA act by the Central Government for a period of one year, i.e., from 30 January 2003 till 29 January 2004. This exemption is subject to the condition that RF(I) shall assume full responsibility, on behalf of Rotary Clubs and districts in India for the proper utilization of the Foreign Contributions and submission of full accounts of its utilization. Since the exemption is only for a year, TRF and RF(I) encourage Rotary clubs/districts of India to be registered under FCRA, so that their future programs do not suffer in case the FCRA authorities do not grant an extension. Please note the RF(I) exemption does not include trusts/societies.

# MATCHING GRANT AGREEMENT FORM MATCHING GRANT #58851

This Matching Grant Agreement ("Agreement") is entered into by and between Rotary Club of Nitte, Rotary Club of El Camino Real ("The Partners") Rotary Foundation (India) ("RF(I)") and The Rotary Foundation of Rotary International ("TRF"). RF(I) and TRF agrees to pay the Partners a Matching Grant in the total amount of INR253,125.00 equivalent to US\$5,625. In consideration of receiving this Matching Grant from RF(I) and TRF, the Partners acknowledge and agree that:

- 1) The Partners have each received and read a copy of the Terms and Conditions of Matching Grant Award and will abide by all terms and conditions set forth therein.
- 2) Rotary Club of El Camino Real will coordinate the project and will contribute INR 112,500 equivalent to US\$2,500 to the project. Rotary Club of Nitte will coordinate the project locally and will contribute INR225,000.00 equivalent to US\$5,000 to the project. The following district will provide SHARE (DDF) Fund contributions: D 5340, INR 84,375 equivalent to US\$1,875. Any amount received in excess of the aforementioned contributions will automatically be counted as general giving to The Rotary Foundation and will not be applied to Matching Grant # 58851.
- 3) All Matching Grant funds provided by RF(I) and TRF for this project shall not be used for any purposes other than those approved by RF(I) and TRF. RF(I) and TRF shall be entitled to receive reimbursement for any and all funds deposited with, held by, or otherwise contributed to either or both of the Partners that are spent for unapproved purposes as well as any funds used to benefit a Rotarian or Rotary entity. In addition, RF(I) and TRF reserves the right to audit the project at any time and suspend any or all payments if in its sole discretion progress is not considered to be satisfactory.
- 4) The Partners will keep RF(I) and TRF informed on the project's progress by submitting progress reports for the periods ending September and March every year. The Partners will immediately inform RF(I) and TRF of any significant problems with the implementation of the project or deviations from the project, including deviations in the budget. The Partners will submit the final report with complete financial accounting within two months of the project's completion.

For India specific grants, please ensure that all reports **must** be sent to RF(I) for the periods ending 30 September and 31 March, with reports due by 30 November and 31 May. Audited accounts are mandatory with Final Reports and 31 March Report. Along with the Final Report and 31 March Report, original financial documents including receipts and vouchers must be included in the reports. In order to ensure closure of grant files by RF(I) and TRF, all requirements must be met as stipulated by RF(I)

- 5) The Partners shall defend, indemnify, and hold harmless RI, TRF, RF(I) their respective directors, trustees, officers, and employees (collectively "RI/TRF/RF(I)") from any and all damages, losses, judgments, costs, fines, awards, liabilities, or expenses, including without limitation reasonable attorney's fees and costs of litigation, asserted or recovered from RI/TRF/RF(I), that result or arise directly or indirectly from the project including any acts or omissions of the partners.
- 6) The entire responsibility of RF(I) and TRF is expressly limited to payment of INR 253,125.00 equivalent to US\$5,625 plus all SHARE fund contributions. Neither RI nor TRF nor RF(I) assumes any further responsibility in connection with this project.
- 7) RF(I) and TRF reserves the right to cancel this Agreement without notice upon the failure of either or both of the Partners to abide by terms set forth in this Agreement and the Terms and Conditions of Matching Grant Award for Projects in India. Upon cancellation, RF(I) and TRF shall be entitled to a refund of any Matching Grant funds, including any interest earned, that have not been expended pursuant to the terms and conditions of the approved Matching Grant project at the time of cancellation.
- 8) This Agreement will automatically terminate in the event of the failure of either or both of the Partners to comply with the Matching Grant Terms and Conditions for Projects in India due to an act of God, strike, war, riot, civil unrest, hurricane, earthquake or other natural disasters, acts of public enemies, or any reason beyond the reasonable control of the parties. In such an event, the Partners shall refund to RF(I) and TRF all unexpended Matching Grant funds within 30 days of termination.
